Purpose of the Photoshoot

- 1.1 The purpose of the photoshoot is to provide the Photographer to expand his portfolio & the model Images to do whatever she wants with them.
- 1.2The Model agrees to pose for the Photographer, and the Photographer agrees to take photos of the Model.
- 1.3 There will only be a maximum of 3 people allowed present at the shoot, the Photographer, the Model & whoever the model wishes to bring along as a chaperone

TFP Terms

- 2.1 Thiis is a Time for Print (TFP) agreement, which means the model will not receive any monies for the photoshoot.
- 2.2 In exchange for the Model's time and talent, the Photographer agrees to supply a copy of all images taken directly after the shoot written to CD or written to a USB Media Stick/Device supplied by the Model.
- 2.3 The Model & Photographer are entitled to use the Photos for either personal or promotional use.
- 2.4 The Model confirms that they voluntarily & knowingly consent to use of the images with

their Face Shown / Face Not Shown (delete as required).

Photoshoot Schedule & Duration

- 3.1 The date, time and location of the Photoshoot will be mutually agreed upon by the Photographer & Model.
- 3.2 The parties will make a reasonable effort to be present at the agreed location on time & will promptly notify each other in case of any delays or changes.

Photographer's Responsibilities

- 4.1 The Photographer is responsible for providing the necessary equipment and other tools to carry out the photoshoot.
- 4.2 The Photographer will act professionally while photographing the Model.
- 4.3 The Photographer will write all images to a laptop/USB media stick/media card supplied by the model or will write all the images to CD before she leaves.
- 4.4 The Photographer has the right to edit the photos taken & will be written on CD for the Model to collect within 7 days.
- 4.5 The Photographer agrees that the Model has the right to use to the images to do whatever she wants with them.

Model's Responsibilities

- 5.1 The Model will tell the Photographer the type of images she wants before the shoot & has the right to add to the style of photographs she wants during the shoot.
- 5.2 The Model is responsible for providing suitable clothing/lingerie, makeup & accessories for the Photoshoot.
- 5.3 The Model will conduct themselves professionally during the Photoshoot.
- 5.4 The Model agrees that the Photographer has the right to use the photos for their portfolio or online, unless otherwise agreed in writing.

Use of Partially Nude, Nude & Adult Images

6.1 If the Model requires Nude/Adult Images, the Photographer & Model agree that they will be within the boundaries of legal requirements. The model agrees & understands that these uncensored images may depict parts of her body that may be considered intimate, suggestive or of an adult nature.

Copyright & Ownership

7 The Photographer & Model both retain the rights of joint ownership to all photos taken during the Photoshoot.
